This product does not contain wheat, gluten, corn, yeast, soy, egg, dairy products, or artificial colors, sweeteners, or flavors. This product also does not contain lactose, palmitic acid, or magnesium, calcium, or vegetable stearates.

HOW SUPPLIED

AR-Encap[®] is supplied in bottles of 240 two-piece vegetarian capsules. Packed 12 bottles per case.

CONTRAINDICATIONS AND WARNINGS

This product is contraindicated in a patient with a history of hypersensitivity to any of its ingredients.

AR-Encap contains glucosamine, which is derived from shellfish.

AR-Encap contains curcumin phytosome, which is a plant extract complexed with phosphatidylcholine, which is derived from soy. Phosphatidylcholine contains no soy protein. There are no other soy-based ingredients in AR-Encap.

INTERACTIONS

As curcumin, an active ingredient in turmeric, has been shown to reduce the therapeutic efficacy of cyclophosphamide (Cytoxan) in animal studies, the concurrent use of these two agents should be avoided.

PREGNANCY WARNING

A patient who is pregnant or nursing, or who might become pregnant, should consult a health-care practitioner before using this product.

DOSAGE

Adult patients: 2-4 capsules twice daily, or as otherwise directed by a health-care practitioner.

STORAGE

Store tightly sealed in a cool dry place, away from direct light. Keep out of the reach of children.
