Mediclear Plus® is supplied in bottles of 32.45 oz. Net Wt. Packed 6 bottles per case.

**CONTRAINDICATIONS AND WARNINGS**

This product is contraindicated in a patient with a history of hypersensitivity to any of its ingredients.

**INTERACTIONS**

Folinic acid supplementation is not recommended concurrently with methotrexate cancer therapy, as it can interfere with methotrexate's anti-neoplastic activity; however, folinic acid has not been shown to interfere with the anti-inflammatory activity of methotrexate. A patient taking methotrexate for psoriasis, rheumatoid arthritis, or juvenile rheumatoid arthritis can safely take a folate supplement.

MediClear Plus contains Curcumin Phytosome, Grape Seed Phytosome, and Green Tea Phytosome, which are plant extract complexed with phosphatidylcholine which is derived from soy. There is no other soy-based ingredients in MediClear Plus.
